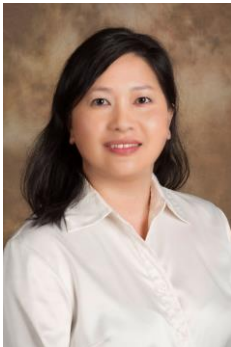
## Dr. Brad Hardee

## Lynne Laws, DNP, FNP-BC



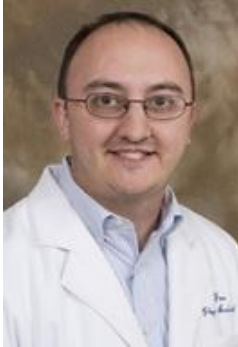
